The World Cup is running in parallel with the International Open Baja Cup (Bike, Quad), with separate regulations, starting after all FIM competitors, using the same special stages in the same time.

Any entry which is not accompanied with the entry fee will be considered as a preliminary one.

3.6 REIMBURSEMENT

The entry fee shall be refunded in full:

- if the event does not take place
- to teams whose entry application is rejected

The organiser may partially refund entry fees, if a competitor cannot take part in the event due to a duly proved case of force majeure. The deduction will be:

- 50% of the entry fee for the requests received until 20 days before the administrative checks.
- 100% of the entry fee for the requests received less than 19 days before the administrative checks.

3.7 ADMISSION OF DRIVERS

The Organizing Committee reserves its right to reject a competitor's entry without explaining their decision.

In order to register at any event of the Bajas World Cup, any driver of any nationality being over 18 years old, must hold a FIM competitor license for FIM Cross-Country Rallies World Championship or Bajas World Cup, valid for the year of the event (art.70.2.1 of the FIM Sporting Code and art. 09.1 FIM Medical Code), released by his NMF, and a driving license corresponding to his vehicle's capacity.

A competitor registering at the HunGarian Baja, does it with full awareness of the risks included in this event. The rider releases in advance to the Organizer, his NMF and FIM by any penal or civil responsibility in case of damages or injuries occurred along his participation at HunGarian Baja.

4. INSURANCE

4.1 TRAFFIC INSURANCE:

Third party risk insurance (Traffic insurance) is compulsory for all crews taking part in the rally. All competitors must have a traffic insurance policy and present it at the administration checking. This insurance is valid both on road sections and special stages.

4.2 INSURANCE COVER:

Name of the insurance company:

SRC SPECIAL RISK CONSORTIUM GMBH, Kuniberts Kloster 7-9, D 50668 KÖLN.

The limit of the responsibility is 3.000.000 Eur.

In case of an accident leading to insurance event, the competitor or his representative must make a written statement to the Clerk of the Course, the Competitors Relations Officer, or directly to the Organizer, within 24 hours. This statement must mention the accident circumstances, the names and addresses of the casualties, as well as contact details of the witnesses.

Loss or injury that may be suffered by the drivers themselves or participating vehicles is EXCLUDED. Irrespective of this Third Parties insurance, entrants and drivers are free to take out the policies they deem fit on their own account and at their own discretion. Service vehicles, including those displaying the plates supplied by the Organization, shall under no circumstances be deemed participating vehicles. They are therefore not covered by the Organization's insurance policy and responsibility for them lies solely with their owners. In case of accident, competitors and drivers exempt the event organizers from any liability and waive any right to bring claims against them.

The insurance cover will come into effect from the administrative checking and scrutineering for the Event and end upon the expiry of one of the following time limits, whichever is the later:

- time limit for protests or appeals or the end of any hearing by the Stewards;
- end of the administrative checking and post-event scrutineering;
- end of the prize-giving

5. ADVERTISING / IDENTIFICATION

5.1 COMPETITORS ARE ALLOWED TO AFFIX ANY KIND OF ADVERTISING ON THEIR VEHICLES, IF:

- a) They are authorised by FIM regulations and by the laws of the Country
- b) They are not against public decorum.
- c) They do not prevent the use of the reserved spaces to the number holder plates and to compulsory advertising of the Organization.

5.2 RESERVED SPACES FOR ORGANIZER ADVERTISING:

The logos will be published in Bulletin

- 1 - Three race number panels with compulsory advertising 20 x 20 cm on each side and on the front of the vehicle
- 2 - One rally plate placed vertically at the front of the vehicle
- 3 - One race number panel with compulsory advertising 30 x 30 cm to the back of the Riders jacket
- 4 - Advertising sticker (30x30 cm-can be cut to so that it can be easily affixed)

Compulsory or optional advertising absent or incorrect affixing will entail a penalty of 50% of the entry fees. In case of repeated offence, it will go up to exclusion.

6. TYRES

Tyres normally available from commercial or retail sources are authorised. Riders will be free to choose tread pattern and compound.

Both tyres, front and rear, must have an "E" mark and/or DOT (American Department of Transportation) approval and the DOT number must be molded on the tyre wall.

7. FUEL

According to Art. 82.9 of FIM Bajas World Cup Regulations

On SS2A, SS2B and SS3A, SS3B will be a Neutralization Zone for all Competitors and a separate Remote Refuelling Zone (RRZ) for Motor, Quad, SBS vehicles only.

8. ADMINISTRATIVE CHECK

Before Administrative Check, each vehicle must **Register** at Suzuki Mészáros, Grábler Tó str.10, where the Checklist and Service Plates will be provided.

8.2 TIMES/ SCHEDULE:

Friday 05. August 2022. 07:00-12:30

The scheduled times for the Administrative and Technical Check for each competitor will be published on the official website www.hungarianbaja.com and communicated to all crews by email on 29.07.2022.

A time control before the Administrative Checks (C1) will be set up, according to the individualized timetable, as well as after the Administrative Checks.

Any delay to the C1 control will be penalized as follows:

- From 1 to 15 minutes: 150€ fine
- From 16 to 30 minutes: 250€ fine
- From 31 to 60 minutes: 500€ fine
- More than 60 minutes: 500€ fine and report to the Stewards.

9. TECHNICAL SCRUTINEERING

9.1 LOCATION: Suzuki Mészáros, Grábler Tó str. 10, 8100 Várpalota, GPS: N47°11'58, E18°19'13

9.2 TIME/SCHEDULE: Friday 05. August 2022 07:30-12:30

The scheduled times for Administrative and Technical Check will be published on the official website www.hungarianbaja.com, and communicated to all crews by email, on 29.07.2022.

There will be a time control before the Scrutineering (C3). The competitors should check-in to this time control according the individual schedule.

Any delay to the C3 control will be penalized as follows:

- From 1 to 15 minutes: 150€ fine
- From 16 to 30 minutes: 250€ fine
- From 31 to 60 minutes: 500€ fine
- More than 60 minutes: 500€ fine and report to the Stewards.

9.3 REQUIREMENTS AT TECHNICAL SCRUTINEERING:

- Vehicles must presented with all start numbers, rally plates, and advertisements afixed properly on the designated place.
- Tracking equipment and inter-vehicle signalling system installed and operable even when the ignition removed, it is compulsory to provide 12V
- Scrutineering Sheet- filled up
- Competitor's helmet

9.4 INSTALLATION OF THE SAFETY TRACKING SYSTEM AND NAVIGATION SYSTEM

9.4.1 TRACKING AND NAVIGATION SYSTEM (NAV-GPS)

All vehicles must only be fitted with the Safety Tracking System(s) provided by the Organiser. The instruction for the use of the Tracking System is in the Appendix 5 of these Supplementary Regulations. Delivery and installation of the equipment will be carried out before the administrative checks. Every competitor must return the equipment at the end of the competition, or, if a crew retires- to the STELLA Crew.

9.4.2 CONNECTION OF THE SYSTEMS

It is the competitor's responsibility to ensure that the Safety Tracking System(s) and the NAV-GPS always remain permanently connected and switched on with the antenna connected throughout the duration of the

competition.

9.5 PARC FERMÉ

Following the technical scrutineering, each vehicle must be set in Parc Fermé up to 15:00.

Location: Szabadság Tér, 8100 Várpalota

10. QUALIFYING STAGE (QS)

Qualifying Stage will be held on 05th August 2022 16:45.

This stage must be performed for each competitor. Any delay in reporting to the start of the Stage will be penalized at the rate of one minute per minute's delay. Vehicles arriving more than 30 minutes late will not be allowed to start. For the QS, times will be taken in hours, minutes, and seconds.

In case of dead heat, priority will be given to the crew who achieved the time first. It shall count for the classification of the event. Any road or other time penalties incurred will be taken into account for the general classification of that leg and applied the same day but will not affect the starting order of the following selective section except for such penalties involving jump starts, shortcuts, or other matters which materially affect the competitor's performance on the QS itself. Start order of the Leg1 Section2 is the QS overall order, Bikes and Quads are together.

11. START OF THE EVENT

11.1 PUBLICATION OF START LISTS: According to Programme.

11.2 BRIEFING:

LOCATION: Thury Castle, Hunyadi Mátyás Tér 1., 8100 Várpalota

TIME: Friday 05.08.2022 at 15:45

Briefing is compulsory for each competitor, who must confirm his presence by signature.

11.3 ROAD BOOK PROVIDING: at the BRIEFING.

12. RUNNING OF THE EVENT

12.1 PARC FERMÉ BEFORE THE OFFICIAL START

In Start Parc Fermé, crews should be ready 15 minutes before the individual ideal starting time.

12.2 TIME CARD PROVIDING/EXCHANGES

Time cards will be issued before the Start of each Leg, which must be submitted to the marshalls at the Finish of each Leg.

Time card exchanging: at regrouping.

12.3 STARTING PROCEDURE FOR THE SPECIAL STAGE will be as follows:

The start of the selective section is happening based on an electric clock and lamp, connected to a false start alert system. A digit display will show continuously the time progressing.

The Marshalls will call out loud the 30, 15, 10 seconds then point towards the start equipment. Beginning from the 55 seconds, red lights will be flashed per every second, then at 00 seconds the red lights will go off and below, the green lights will go up. This will be the time to start.

In case the equipment goes wrong, the marshals will change to manual starting procedure.

12.4 After Leg 1, and for the following legs, the start will be given following the order of the Selective Section Classification of the previous leg and every 1 minutes.

In case of 2 or more successive selective sections, the starting order of the next day's leg will be drawn up by cumulating the times of these selective sections. In case of an ex aequo, priority will be given to the crew who achieved the fastest time in the 1st selective section.

Any vehicle reporting late for the start of a Leg shall be penalised at a rate of one minute for every minute of lateness. If lateness exceed 1 hour the start will be refused (Ref. Art. 82.15.1), or receive a Fixed Penalty where appropriate.

12.5 CLOSED CONTROL

Control post must be ready to function 1 hour before the target time for the passage of the first crew. Unless the clerk of the course decides otherwise, they will cease to operate 1 hour after the target time for the last crew, plus the maximum time allowed for the last competitor.

Any crew with a delay higher than 30 minutes at any time control, will have the start refused for the following section, but will not be eliminated from the event.

Penalty to be imposed will be:

30 minutes for the delay in this control, adding the penalty for not taking the Start in the following SS, and adding the maximum time authorized for the selective section not completed.

12.6. EARLY CHECK-IN AT END OF LEG

12.9. RECONNAISSANCE

Reconnaissance of the route (exception QS by walk or nonmotorized bicycle) is totally forbidden. Possession of route notes or other informations different from those given by the Organization is forbidden. Penalty decision at Jury's discretion.

The only official route is that set out in the Road-Book.

To help competitors, the Organizer will indicate intersections and features of the route by means of arrows and tapes. The Road-Book shall be the only official document to be followed.

13. FIXED PENALTY

TIME CONTROLS – MAXIMUM TIME ALLOWED – PENALTIES

A maximum lateness of 30 minutes for every Road section and a total lateness of 30 minutes in road sections of a Leg is authorised. This lateness will be penalised at a rate of 1 minute per minute or fraction of minute according to the Art. 38.8 of General Prescriptions 2022.

14. SERVICE PARK

14.1 LOCATION:

GÁL GYULA SPORS HALL parking lot (with shower and toilet facility in the Sports Hall)

8100. Várpalota, Fehérvári str. 9.

Servicing a competing vehicle will be permitted only at service areas specified by the Organization. Repairs that may be carried out by a team using on-board equipment or equipment carried by another participant in the race are authorized along the whole route. Any other external servicing outside the authorized areas is forbidden and shall be penalized by EXCLUSION at the Jury's discretion.

14.2 ACCESS TIMES FOR SERVICE VEHICLES

According to Programme.

14.3 OPERATION OF THE SERVICE AREAS

Entry will be permitted only to Service Vehicles showing the Service Plates. Accompanying team cars can enter only by purchasing a 100€ sticker at the Administrative Checks. Tampering with or falsification of the Service Plates will lead to disqualification of the team to which these service vehicles belong.

The Service Plates will be placed in a visible area of the front windscreen of the vehicle. Each crew will receive one Service Plate free.

The maximum speed allowed in the service parks is 30 km/h

Using a min 2x1m protector groundsheet under the racing vehicles is mandatory. 1pc at least 4kg validated manual fire extinguisher is mandatory. Each service team has to ensure that after carrying out their activities on the site, they do not leave any pollutants. They will be checked by the scrutineers, and not complying will entail a 50.000HUF fine.

Washing and Refuelling is strongly prohibited in the total area of the Service Park!!!

The Organizer calls the attention of the participants, that the Service Park is not guarded at night time!

14.4 REFUELLING

Refuelling is permitted only in commercial fuel stations using fuel on sale to the public. Only the crew may carry out this procedure.

On SS2A, SS2B and SS3A, SS3B will be a Neutralization Zone for all Competitors and a separate Remote Refuelling Zone (RRZ) for Motor, Quad, SBS vehicles only.

The Refuelling station authorised will be indicated in the Road Book with "FUEL STATION".

15. FINAL CHECKS / PROTEST / APPEALS

15.1. FINAL CHECKS

Time and location: see Programme

Any teams required to undergo final checks must immediately follow the instruction of the marshals in charge, even if this prevents them from proceeding to one or more time controls (TC).

15.2. PROTEST

Any complaint shall be presented according to requirements of the Disciplinary and Arbitration Code. They must be submitted by writing to the Clerk of the Course, within the required dates, by the concerned competitors and not by third parties.

APPENDIX 4. – GPS TRACKING SYSTEM'S INSTALLATION KIT

IMPORTANT

For the functional tests and verification, all vehicles must have gone through the installation of the mount, power cord, and antennas.

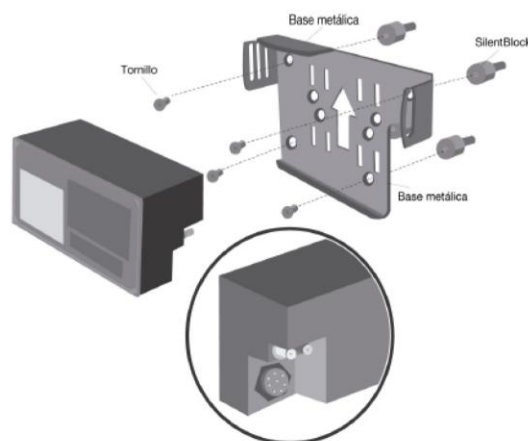
1. POWER CORD

- Connect the red wire to the positive end of the battery 12V(+), and the grey wire to the negative end (GRD). The power cord must be connected directly to the battery (without interruptions and without contact in the power supply).
- A 3A fuse (not included) should be connected to the red wire.
- Take the cord to the location in which the STELLA III EVO is to be installed. All other wires must be insulated, they cannot touch.



2. BASE/MOUNT

- Motorcycles and ATV: The mount can be attached to the handle bar or to a metal plaque close to the navigation system.
- Cars and UTV: The mount can be attached to the panel, or to the roll cage bars. STELLA III EVO buttons must be visible and accessible to the participant (pilot/navigator) even when they are sitting and with the seatbelts buckled.



IMPORTANT

Leave the cords (antenna and battery) in place with at least 10 cm to spare for easy handling.

At least 5 cm of space behind the mount (bottom right corner) to allow space for power cord/connections.

3. GPS ANTENNA

The GPS antenna must be installed horizontally and without obstructions toward the sky. In cars and UTV, It can be mounted on the roof, the hood, or the dashboard. In motorcycles and ATV, attach to the mudguard. For additional firmness, it is recommended to cover it with adhesive tape (non metallic when mounting it to a metallic surface) and pull-up (when attached to soft or plastic parts).



4. ANTENNA IRIDIUM

The Iridium antenna must be installed horizontally and without obstructions toward the sky. In cars and UTV, It can be mounted on the roof, the hood, or the dashboard. In motorcycles and ATV, attach to the mudguard. For additional firmness, it is recommended to cover it with adhesive tape (non metallic when mounting it to a metallic surface) and pull-up (when attached to soft or plastic parts).



5. RF ANTENNA

The radio-frequency antenna must be installed vertically to the roll cage bars (cars and UTV) and the forks (motorcycles and ATV). It is mandatory to use separators (included in the kit) to avoid contact with metallic parts and the carbon fibre that surrounds it.

Once the antennas are mounted, take the SMA connection cords to the base/mount where the STELLA III EVO will be installed.
